#### LAKE LOWERING

The New Jersey Department of Environmental Protection Fish and Wildlife Section will allow Medford Lakes Colony to apply for permission to lower the water level of a lake by as much as 3' (depending on the lake) in October. If you would like the lake you live on lowered, please send a request to office@medfordlakescolony.org or call 609-654-7747.

So far, the following lakes have had lake front homeowners' email to ask to have the lake lowered:

Ballinger Lake from 10/1 - 10/15 • Kawasea Lake from 10/15 - 10/29Lower Aetna Lake from 10/1 - 10/15 • Meeshaway Lake from 10/15 - 10/29Mishe Mokwa Lake from 10/15 - 10/29 • Siguitise Lake from 10/15 - 10/29Upper Aetna Lake from 10/15 - 10/29

Remember, if you do any work to your dock or/and bulkhead, it is necessary to complete an application/permit with the Medford Lakes Colony. There is a \$25 application fee. The applications can be found on our website: https://www.medfordlakescolony.org/forms.


